General information

#### 6. Accidental release measures

Methods and materials for containment and cleaning up

Take precautionary measures against static discharge. Use only non-sparking tools. The product is insoluble in water and will spread on water surfaces. Prevent product from entering drains.

#### 7. Handling and storage
