Methods and materials for containment and cleaning up

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Absorb spillage with suitable absorbent material. Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use. Wipe up with absorbent material (e.g. cloth, fleece). For waste disposal, see section 13 of the SDS.
