SECTION 4- FIRST AID MEASURES

<u>INHALATION</u>	 Remove victim to fresh air. Artificial respiration should be given if breathing has stopped and cardiopulmonary resuscitation if heart has stopped. Oxygen may be given if necessary. Seek medical attention immediately.

Mild alcohol intoxication occurs at blood levels between 0.05-0.15% and approximately 25% of individuals will show signs of intoxication at these levels. Above 0.15% the person is definitely under the influence of ethanol and 50-95% of individuals at this level are clinically intoxicated. Severe poisoning occurs when the blood ethanol level is 0.3-0.5%. Above 0.5% the individual will be comatose and death can occur. The unabsorbed ethanol should be removed by gastric lavage after intubating the patient to prevent aspiration. Avoid the use of depressant drugs or the excessive administration of fluids.
